This approach can be used in processes of choosing strategies, setting goals and objectives. Although the concept of remote work is not new, it requires parlicular attention to some aspects of the work organization: setting a daily routine, maintaining communication and ensuring the well-being of employees. All these factors affect the efficiency of employees.  During this session, we invite companies to share their experience: how to organize properly the workflow, work space, eliminate the risk of accidents and provide remote employees with safe workfing conditions.
3	20.04.2021	Environment & Sustainable Development	Environmental safety — priority for business development	More than 20 years ago, the UN proposed to focus the attention of the international community on natural resource conservation in the whole world. More and more attention is paid to ensuring the environmental safety of production processes. New mechanisms and institutions of interaction between the business community at both the international and national levels are being formed.  Now it is no longer possible to limit ourselves to the implementation of legislative requirements. We need progressive approach, that would take into account current trends. The international agenda requires active actions to develop and conduct sustainable business.  During the round table, participants will consider the existing request for improving the effectiveness of the environmental management system and discuss the role of environmental aspects in the planning of the company's activities.

4	27.04.2021	Health & Culture of Well-Being	Simple steps towards health culture	"Culture of health". What is it? What is it for? This is a very complex concept that requires taking into account many aspects of the work and lifestyle of employees. Currently, leading experts realise that there is a problem of improving the culture of health and safety of employees in companies.  Many socially responsible enterprises are already implementing preventive measures to maintain the health of their employees. However, the question arises as to whether they are effective and commensurate with the staff workload. Physical exercises are definitely a good thing. However, the prevention of diseases and injuries should be diverse and holistic.  The key to solving this issue is the implementation of comprehensive measures aimed at maintaining the health of employees. Planned investments in creating conditions that promote the well-being of employees are recaptured in a short time
				and bring economic and trend benefits to the company.  During the expert session, we will consider practical tools and mechanisms for their implementation in the company's activities to effectively improve the health culture of employees.

The international dialogue is dedicated to the combating of outbreaks of infectious diseases in the workplace, with special attention to the activities of specialists in the field of labor protection. In an open dialogue we will discuss how each of us has met this challenge and what lessons we have learned.

These instruments are created with consideration of social, environmental and economic aspects. Thus, in order to demonstrate an effective management system and to assess the company's capabilities and risks for the long term, international rating system have been developed.  Such ratings can be used to select partners and attract investments. As a result, the safety of the company's activities for the environment and people becomes one of the key factors of business development and this should be taken into account in the strategic planning of the company. Thus, in addition to external interaction, ratings can be useful for internal benchmarking and decision-making.  We invite to join our discussion. The participants will talk about the importance of using such tool as the ESG rating in the strategic development of the company and the role of occupational safety in this context. The foresight session will also cover the organization of production processes and environmental protection within the enterprise, as well as the opportunity for companies to share their relevant experience.

2	14.09.2021	Digital Transformation	Wearable devices: not just an accessory	The future belongs to wearable devices, All of us have ever used smart watches, bracelets, calorie counters, etc. Every day we come across one or another type of smart wearable device, use it as a technological accessory or for entertalmment. Today high technologies are available to everyone, they simplify many life processes. Let's now imagine how you can use all this arsenal in production, in the organization of labor protection. What will happen if we use smart wearable device technologies to reduce employee injuries, implement them to improve safety and reduce the risk of accidents. We have thousands of sensors at our disposal that can work in a single ecosystem, performing continuous monitoring functions.  During the round table, we will look at all available types of such devices that can already be used on a production scale, get acquainted with the possibilities of their application and find out what tasks they solve. 1	05.10.2021	Health & Culture of Well-Being	Prevention of air-borne infections	A pandemic is a global outbreak of a disease that can be caused by a variety of agents, including influenza and coronaviruses. However we should not forget about seasonal infectious diseases.  The transmission can occur in the workplace, not only from patients to health care workers, but also between colleagues, members of the general public and workers in other types of workplaces.  All this requires a special attitude to the organization of work and working premises equipment.  During the practical session, we will consider the importance of an integrated approach to the microbiological protection of personnel: organizational, technical and technological methods of protection in the workplace.

2	12.10.2021	Human Capital	HSE Super Team	Good teamwork is essential for high efficiency in any business. Good teamwork creates synergy — when the cumulative effect of the team is greater than the derivative of individual effort. Working together, a team can apply individual perspectives, experiences, and skills to solve complex problems, creating new solutions and ideas that may be beyond the capabilities of any individual. Good teamwork provides mutual support and learning, and can generate a sense of belonging and commitment.  The implementation of Vision Zero is not an exception. The HSE team is the most important thing, all other processes are built around it.  During the session, experts will discuss the details and subtleties of finding and selecting key team members and their training. We will learn how to build communication effectively, what methods of retaining and adapting new candidates in the company can be used. The speakers of the session will answer the key issues on the Human Capital track agenda, as well as talk about practical tools for HR management of HSE teams.

1	02.11.2021	Environment & Sustainable Development	Prevention of environmental disasters	The COVID pandemic happened unexpectedly for the whole world, companies and their employees faced a huge number of problems, the solution of which required time and sacrifices. The same thing will happen if any other global environmental disaster occurs.  Assessment of the state of preparedness for the expected disaster, the actual response to the onset of a cataclysm, measures for recovery after a disaster — all these stages require coordination of actions of all participants.  The session is devoted to the discussion of tactics and strategies for the development of companies if the environmental disaster occurs. What tools do we have today to act proactively at the preparatory stages and effectively organize work to eliminate negative consequences in case of an emergency? What innovative solutions to problems exist today that can significantly reduce the negative impact?  The paradox of disaster preparedness is that it covers everything except what actually happens. We must be prepared enough to meet any unforesseen disaster.
2	09.11.2021	Global Dialogue	Multinational companies: a unified approach	International companies with branches all over the world are an example of a successful business. However, geographical expansion entails the emergence of a number of new problems that require close attention.  Rules and regulations that apply in one country may not apply in the other state where the business operates. It is extremely important to assess the problems of compliance with the requirements of local legislation, to balance the company's corporate standards with national regulation.  The participants of the global dialogue will discuss important issues that need to be kept in focus by international business when developing new territories. Experts will tell how to build effective cross-cultural communication processes, offer instructions for standardizing business and working processes within the company.
3	16.11.2021	Health & Culture of Well-Being	Telemedicine: trend or new reality?	Today intelligent solutions are being implemented increasingly in the field of occupational safety. This process increases safety at the workplace and turns it into a well-controlled process.  As part of the dialogue, we will analyze what the modern online medicine market is: what types of services exist, and what areas are most popular and in demand.  Experts will help to understand whether telemedicine is a temporary trend or a better and easier way to organize medical support for employees.
4	30.11.2021	Digital Transformation	lloT: monitoring systems	A smart vacuum cleaner, a toothbrush, a remote switch-on system for household appliances, and other devices are common components of a modern home. It's time to include smart sensors and other smart devices into work areas and production sites. To ensure a safe working environment, the most important aspect is the availability of the necessary data at the time when it is needed. Traditionally, we spend a large amount of working time collecting, processing and analyzing information.  The industrial Internet of Things allows to automate the entire cycle. The data is available always and immediately, after processing and analyzing key indicators. Online monitoring systems allow us not to perform routine work, but concentrate on building hypotheses, testing theories and implementing various solutions to improve working conditions.  During the session our task is to show the best practices. Invited experts will share their experience and discuss possible tools for implementing smart technologies in production processes.

1	07.12.2021	Safety & Risk Management	Advanced and effective PPE: latest trends	"Personal protective equipment" (PPE) — until recently, this phrase could be heard only in specialized industries, harmful and even dangerous for employees. However, the events of 2020 have also made their own adjustments in this area. Medical masks and gloves in public places have become an integral part of our everyday life.  In addition to expanding the scope of application, PPE itself is also evolving. Now the global PPE market is preparing to make a new technological leap that will change our perception. The concept of smart applications, which connect PPE with the Internet and allows to transfer a lot of data, is already becoming a reality.  We invite participants to discuss innovations and trends in the PPE market, to consider the key factors of implementation and ensuring the work processes.
2	14.12.2021	Human Capital	Staff training in "imperfect" conditions	Not all employees of the company work centrally, in one place. Due to objective reasons, very often branches of companies are located in hard-to-reach places. In this regard, effective models of distance learning and online support are needed for continuing operational training and professional development of specialists in remote areas.  During the event, companies that are faced with the problem of remote or "inconvenient" location of branches and divisions will talk about their experience in implementing distance learning practices.

3	21.12.2021	Digital Transformation	Big Data	Traditionally, HSE departments work with a large amount of information: working conditions for each workplace, hazards, risks, the results of knowledge tests for employees, and much more.  All this data is updated every day, at every facility of the enterprise, in every region, and is representer in a large array of information. It is no longer feasible to analyze data in traditional ways, such as using Excel or other manual techniques. The only sustainable approach that gives a stable and accurate result is to use complex automation and integrated systems. In short, we need to collect all the data necessary for processing and prepare reports in real time.  Today our task is to build these processes at a completely new level, when you can
				quickly and reliably draw thousands of connections between different types of data and get more workable indicators. All this will allow us to achieve high efficiency in decision-making.

1	18.01.2022	Environment & Sustainable Development	Effective waste managment	Waste management is one of the important issues of environmental policy. Poor waste management can lead to various environmental problems. The importance of integrating different participants requires a serious approach to its application in order to create a good and sustainable system.  Today it is important to unite international efforts in the search for optimal solutions to reduce the negative impact on the environment.  Join us at the event dedicated to waste management, participate in the discussion and search for safe and cost-effective solutions in the field of waste management and disposal.
2	25.01.2022	Safety&Risk Management	Root causes of industrial accidents	Everything has its own reason, its own prerequisites. An accident is the result of a series of events and actions. It is impossible to deal with the problem without identifying its root causes.  We are deeply convinced that the global experience exchange will expand the scope of existing tools for identifying the root causes of accidents and will help to comprehensively approach the effective prevention of dangerous accidents at work.  Within the framework of the thematic round table, experts will discuss how important it is to investigate the accident and find its root causes. Participants will get to know different approaches to identify root causes, so that they could later use new techniques in organizing safe working conditions.

1	01.02.2022	Human Capital	Gamification in HSE	Business games, gamification and gaming technologies are no longer just a trend, but a modern effective tool for staff training. The use of gaming technologies in the field of labor protection and industrial safety, where the formal nature of training has historically developed due to its obligation and frequency, is becoming especially relevant. Ignorance and poor quality of training and implementation of knowledge are the main reasons for safety rules violations. As a result the number of injuries at enterprises increase.  Game forms of training have a significant impact on the effectiveness of employee training, allow to improve the involvement and motivation of the participants.  Within the the discussion, experts, game practitioners and representatives of leading companies, will discuss the most successful practices of using game approaches in the field of occupational safety and health.
2	08.02.2022	Safety & Risk Management	Results of the transition to ISO 45001: 2018	On March 12, 2018, the long-awaited ISO 45001 was released. This event has marked the end of more than four and a half years of development cycle. Recognizing the importance and far-reaching implications of the new standard, occupational safety experts and industry organizations responded positively.  The security requirements and protocol vary by industry and work site. One of the advantages of the ISO 45001 standard is that it is flexible enough to be implemented in almost any organization.  We invite participants to share their experience, how the transition and certification under the new standards took place, and what are its advantages for particular industries. Experts will discuss what difficulties companies face when implementing and using the standard.
2	15.02.2022	Health & Culture of Well-Being	A Matter of Life: first aid skills	We believe that first aid should be the main life skill of employees. Anyone may need help when performing dangerous jobs or routine duties. However, it is not enough to hold one webinar. Knowledge of first aid should be regularly reinforced by practice and training.  We will discuss how to effectively organize training and how to motivate employees to practice first aid skills with leading experts during the session.

1	01.03.2022	Human Capital	Psychology - an effective approach to working with the team	Many companies spend significant time and resources to improve safety, usually by addressing technical, environmental, and procedural issues and implementing safety management systems. However, what happens when productivity declines and minor crashes continue to occur? How can we foresee the incidents? How can we prevent those minor incidents that are often attributed to negligence or inattention?  This is where the psychology of safety comes to the forefront. After all, when forming a team, the human factor, the personality of employees plays an important role. Companies face different levels of awareness among workers. This also applies to the safety rules attitude.  During the event we will learn from experts how to create a "portrait" of safety from a scientific point of view, consider effective methods of personnel diagnostics that can be used in the selection and evaluation of the team and investigate the approaches to the formation of awareness of safety issues.

2	15.03.2022	Digital Transformation	Virtual workspace and autonomous technologies	The reality of modern business is that: more and more processes are executed remotely, and significant parts of the workforce are switching to remote work. Many companies, especially manufacturing industries, are located in remote areas. The company's activities can be carried out from anywhere in the world, at any time of the day- all this creates new challenges for the organization of optimal work process.  How to ensure safety in a world where everything is so accessible and remote at the same time?  However, we should not be pessimistic about such changings. In addition to the challenges, new opportunities also arise. A modern company has a huge number of options available for organizing dangerous works independently and remotely. Like movie heroes who fly drones, employees can operate large-scale equipment at coal mines from the head office. These technologies have a huge potential, the most important is the ability to protect people from deadly dangers, which is the direct way to achieve the goal of zero harm!  At the thematic session, developers of such solutions, so as the companies that are already implementing autonomous workplaces, will talk about their experiences, new opportunities they met and difficulties they overcame.
3	22.03.2022	Safety & Risk Management	Audit. Best practices	The one who owns the information, keeps under control the organizational and production processes in the company. The main task of the audit is to systematically and regularly (once a month, every quarter, etc.) present real data on the current situation at the workplace. Thus, it becomes possible to take effective measures in a timely manner and change the existing order within the company. An audit is not a formality, it is much more than just a standard procedure. It is the regular audit that is the main aspect of the PDCA approach.  There are three components we need:  1. a trained team of auditors  2. a well-structured systematic audit process 3. staff with a strong understanding that the purpose of the audit is to protect their health and safety, and not an event designed to identify and punish violators.  This synergy will allow us to form an objective picture of the current state of occupational safety and health.
